CARGO

Cargo insurance covers the shipment of goods from the place of origin to the place of destination, including detentions, trans shipments and normal stay overs during the normal course of transportation.

LOCAL SHIPMENTS

INSURABLE INTEREST:

All stocks, merchandise or goods inherent to the activity of the insured, either belonging to the insured or for which he is responsible or is obligated to insure. Fixed assets. All adequately contained or packaged for efficient and safe transportation.

TERRITORIAL SCOPE:

Anywhere within the territory of the Argentine Republic.

BASIC COVERAGE:

- » Collision.
- » Rolling over.
- » Derailment or falling of transportation vehicle.
- » Collapsing, falling of trees and posts.
- » Fire.
- » Explosion.
- » Lightning.
- » Hurricane.
- » Cyclone.
- » Tornado.
- » Flooding.
- » Mudslide or alluvium.
- » Strikes, lockouts, riots or civil commotion.

Coverage extensions

- » Waiver of recourse against inland shipping company.
- » Malfunction of cooling equipment.
- » Extension of coverage from and to neighbouring countries.
- » Robbery.
- » Loading and unloading.
- » Wetting.
- » Larceny of non-delivery.
- » Robbery whilst loading and unloading.
- » Damage to packaging and labels.

TERRITORIAL SCOPE:

Shipments from abroad to destinations within the Argentine Republic.

Exports

TERRITORIAL SCOPE:

Shipments whose origin is anywhere in the Argentine Republic to destinations outside borders of our country.

MAIN TRANSPORTATION MODALITY

For both coverages the main means of transportation can be:

- » Ocean going ship holds.
- » Warehouses in aircrafts operated by authorized commercial airlines.
- » Land vehicles and trailers of shipping companies that issue international bills of lading listing the insured goods.



COMBINED TRANSPORTATION

This insurance covers the needs of clients who require coverage for shipments within the country and also international shipments englobing imports, exports, or the combination of both.

TERRITORIAL SCOPE:

Local shipments:

Shipments that begin and end within the boundaries of Argentina.

Imports:

Shipments from abroad to destinations within the Argentine Republic.

Exports:

Shipments whose origin is anywhere in the Argentine Republic to destinations outside borders of our country.

COVERED EXPOSURES

In local transits:

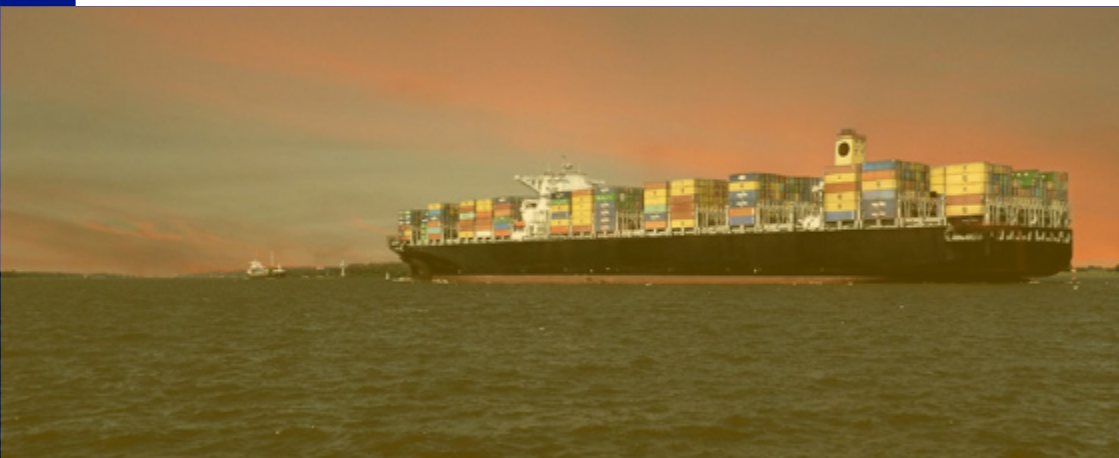
Against all risks of physical loss or damage resulting from an external cause.

In air transits:

Against all risks of physical loss or damage resulting from falling, collision, forceful landing, landing gear failure, fire, explosion or lightning.

In marine transits:

All risks of physical loss or damage resulting from collision, fire, explosion; shipwreck or ship stranding.
